Course Requirements: Participants in the Experienced PIMS Administrator Track will need the following to successfully meet all course requirements:

- Internet access
- Access a Moodle account
- Completion of Entry Level PIMS Administrator Track
- Complete all assigned online coursework on time and receive a 90% or greater average.
