Delete Utility FAQ

What is the PIMS delete utility?

The PIMS Delete Utility, developed by eScholar, provides Pennsylvania Local Education Agencies (LEAs) with the ability to delete data in a specific template from a specific collection according to the parameters set by the PDE.

How do I gain access to the PIMS delete utility?

Access is gained in PIMS production by completing the appropriate Data Quality Curriculum prerequisites specified for the Delete Utility Specialty Module. (<http://www.padqc.org/learn/>)

What do I do if I previously had PIMS delete utility access and no longer see it on my account?

- 1.) Did you change LEAs?
 - Delete Utility access is tied to your MyPDEsuite username and AUN
 - If you have changed LEAs, you will need to request access for your new account.
 - Please reach out to your IU Point of Contact to submit this information.

- 2.) Did you recertify?
 - Beginning the 24-25 school year, with the release of the updated DQC, all individuals that hold the delete utility are required to recertify their status by successfully completing and passing the Experienced PIMS Administrator Exam.
 - Any individual that does not recertify by March 31, 2025 will no longer hold delete utility access until all requirements are met.
 - Access to the delete utility will be restored after successful completion of the Experienced PIMS Administrator Exam.
- 3.) If you have met all the requirements listed above, please reach out to your IU Point of Contact and ask them to send you the Delete Utility Access form to complete.

What deletes are available in PIMS production?

Deletes are opened and available at the discretion of PDE. Below is a list of collections and deletes that are available throughout the year. Remember that the collection must be an open collection in PIMS for the LEA to delete from it.
